## Sisters of Mercy 2024 Fall Money Calendar Sweepstakes Rules

Only one entry per 3x5 card, per envelope will be accepted. Mass-produced entries are not accepted. Entries received from any person in excess of the stated limitation or illegible entries will be void. Entries which are not on the official Sisters of Mercy 2024 Fall Money Calendar entry form must contain all entry fields outlined above; otherwise, they are void and will not be eligible to win. ## **Prize Drawings**

## Winner Notification
